



## **2025 Allrounder Scholarship Application**

**Applications are due to the Scholarship Assessment Committee by Wednesday 30 October 2024**

Allrounder Scholarships will be awarded to students that have the potential and desire to succeed and contribute to the community in a positive way but, without financial support, would not be able to attend the College.

Applications are open to students:

- Enrolled or not yet enrolled in the College, studying in Year 7 to 12 in 2025;
- Who are Australian Citizens or Permanent Residents of Australia; and
- Can demonstrate financial hardship and the need for financial support.

Scholarships will be awarded to students who demonstrate strength and a high level of commitment and involvement in one or more of the areas listed below:

- Academia
- Creative and Performing Arts
- Sport
- Leadership and Citizenship

The application process will require students to demonstrate commitment to, and enthusiasm for, the College's identity and purpose by requiring a personal statement detailing the student's commitment and involvement in their area of strength. It will include a request for detailed financial information that demonstrates a need for financial support.

The value of the scholarship may vary and would offer between 25% and 100% remission of Tuition Fees.

The scholarship is awarded to a deserving student (or students) based on achievement in one or more of the areas outlined above, the candidate's personal statement and demonstrated financial need. Scholarships are generally awarded to students with a positive attitude, leadership skills and a commendable application.

Responsibility for assessing applications, identifying successful recipients and determining the level of scholarship support to be provided rests with the Scholarship Assessment Committee.

Scholarship recipients will be reviewed during each year. The Scholarship recipient must actively participate in College life and co-curricular activities and represent the College with pride. The Scholarship recipient must continue to meet academic and behavioural expectation to continue to receive the scholarship.

The College reserves the right not to award a scholarship in any particular year.
